#### 1. Health

Joint Prakas N0. 302 NUL jun dated 25 March 2016 on rule and procedure of

spending package for strengthening and promoting equity of health services to referral hospitals and health centers of the Ministry of Health and Ministry of Economy and Finance

The purposes of this Joint Prakas are as follows:

- Facilitate the procedure of spending package for operating, strengthening and promoting equity of health services in order to increase effectiveness, quality and equity of these services.
- Improve accountabilities and transparency of the management of spending

package in order to strengthen effectiveness and equity of health services in

referral hospitals and health center.

The targets of the spending packages are for:

- Necessarily monthly expense on the administrative tasks such as purchasing accessorial materials, fixing, and hygiene maintenance and environment.
- Expense on emergency aid.
- Expense on the primary pharmaceutical.
- Advertisement and measures on improving the quality of health services.

The instruction of the detail targets of spending packages and the implementation procedure shall be determined by the instruction on the management procedure of quality and equity improvement of health services of Ministry of Health.

Any provisions contrary to this Joint Prakas shall be abrogated.

## Sub-decree No. 120 HBjfi.Ufi dated 08 June 2016 on Establishment of Social

### Land Concession Department under the General Department of Housing of Ministry of Land Management, Urban Planning and Construction

The duties of Social Land Concession Department are as follows:

- Raise action plan for social land concession committees at national level.
- Cooperate with capital-provincial land management committees for social concession goals.
- Provide technical support to team work in order to prepare plan for management and land using.
- Control and monitor the provision of social land concession. Follow up the improvement on the implementation of social land concession.
- Cooperate with relevant parties in order to collect and compile all data related to social land concession.
- Amend policy and other provisions for Social Land Concession Committees at national level.
- Raise principles, abolish decisions or revise using and dividing land plan at Capital-Provincial Social Land Concession Committees at national level.
- Prepare programs for social land concession at national level and submit the programs to Social Land Concession Committees at national level.
- Follow and evaluate on the implementation of the social land concession program and write reports concerning the working results to Social Land Concession Committees at national level.
- Organize and coordinate meetings of Social Land Concession Committees at national level.
- Raise department budget plan.
- Perform other duties as assigned by General Department.

Any provisions contrary to this Sub Decree shall be abrogated.
