**1. Real Estate**

**Prakas No. 965 សហវ.ប្រក. dated 24 August 2016 on the Management of Housing Development Business**

Objectives of the Prakas are to boost and ensure the efficiency of the management of housing development in Cambodia. It is also to protect the equity, balance and the advantages of the developers and consumers.

The Prakas has goals to determine the measures, rules and procedures of the management and the inspection of housing development business in Cambodia. The extent of this Prakas covers to all activities related to housing development in Cambodia.

Any provisions contrary to this Prakas shall be abrogated.

**2. Labor**

**Prakas No. 341 ក.ប/ប្រ.ក dated 10 August 2016 on to the determination and management of enterprises and establishments in Phnom Penh**

The goal of this Prakas is to strengthen the implementation of the Labor Law and to improve the working conditions such as the hygiene, securities and professional communication.

Enterprises and institutions as follows shall be under the entity of Ministry of Labor and Vocational Training:

1. Textiles, garments and footwear exports
2. Industries
3. The companies that send employee to work oversea
4. NGOs

**Prakas No. 005/16 គ.ម.ក/ប្រ.ក on date 17 August 2016 related to Qualitative Investors in Securities Sector**

This Prakas intends to set conditions and procedures for qualitative investors to participate in various procedures in public securities market and/or securities trading in accordance with Law on Issuance and Trading of Non-government Securities and the sub-decree on the implementation of the Law on Issuance and Trading of Non-government Securities and relevant provisions. The conditions to be qualitative investors are stated in Article 3 of this Prakas.
